

"EXPO-M-GROUP Ltd", in the following referred to as "Organizer", represented by General Director Nisiforov I.A., acting on the basis of the Charter and _____ in the following referred to as "Exhibitor", represented by _____,

AGREED as follows:

1. SUBJECT OF AN AGREEMENT

1.1. In accordance with the Application form (A01), hereinafter referred as "Application", Organizer will provide the Exhibitor with all the services the Exhibitor needs to participate in International Mould Making & Technologies Exhibition "Rosmould2011" (in the following referred to as 'The Exhibition') which Organizer will carry out in "Crocus Exhibition Center", Moscow, Russia. When needed, The Organizer will provide The Exhibitor with the additional services, stipulated in the Appendixes to the Agreement.

1.2. The Exhibition will take place on June 15 - 17, 2011, in "Crocus Exhibition Center", Moscow.

2. RIGHTS AND OBLIGATIONS OF THE PARTIES

2.1. Organizer undertakes:

2.1.1. To organize and carry out the Exhibition in time, according to the present Agreement.

2.1.2. To supply the Exhibitor with the necessary documentation stipulated by the present Agreement.

2.1.3. To provide the number of additional services approved by the Parties in accordance with the Appendixes to this Agreement.

2.1.4. To create and to distribute the Exhibition Advertisement in Mass-Media and to provide the Exhibitor and the persons intending to visit the fair with the information about carrying out the Exhibition and business actions of Exhibitors.

2.2. Organizer reserves the right:

2.2.1. To use the stand at own decision in case the Exhibitor has not moved in to the stand allocated to him till 12 am of the day of opening of the Exhibition.

2.2.2. In case of arising of technical difficulties not stipulated earlier and without any reduction of an exhibition area to change the position and design of the stand of the Exhibitor. In other cases such a change is possible only with the consent of the Exhibitor. The right of the Organizer is to create Exhibition stands lay-out and the introduction of changes to this layout, complete or custom.

2.3. The Exhibitor undertakes:

2.3.1. To pay the participation fee to the Organizer, which includes: cost of the equipped or non-equipped exhibition area given, adjusted for type of the stand extra OR the cost of participation in absentia, registration and insurance payments, in the terms specified in Article 3 of this Agreement.

2.3.1.1. The cost of a given exhibition area is based on the costs of square meter. The area is to be reserved in accordance with the Exhibitor's Application form and according to the provisions of the Article 3.1 of this Agreement.

2.3.1.2. Cost of the equipped exhibition area includes: a) the stand, classically designed, using standard materials with an inscription on a fascia board, the size of which is specified in Space Application Form; b) construction and dismantling works; c) the standard set of furniture; d) electricity supply; e) the general security protection of pavilion; f) tidying up the area bordering the stand.

2.3.1.3. Cost of non-equipped exhibition area includes: a) the exhibition space; b) the general security protection of pavilion; c) tidying up the area bordering the stand. In order to construct double-stored stand, the Exhibitor is to extra pay 50% of the Raw Stand Rate according to the floorspace of the upper floor of the stand.

2.3.1.4. Participation in special events (including public ones), publication of the additional direct information on the participants and also special actions to increase stand attendance rate are separately paid.

2.3.1.5. The registration fee includes: a) issuing of the valid passes (badges) to the Fair, 1 badge will be given for every 3 square meters of the exhibition area rented, but not more than 30, b) registration and publishing of the information about the company in official catalogues of the Exhibition, in the amount specified in the Application form, and on the web site www.rosmould.ru and www.rosmould.com c) 1 copy of the catalogue; The registration fee is to be taken from every Exhibitor, but the co-exhibitors pay only the co-exhibiting fee.

2.3.1.6. Cost of an insurance payment makes 1 % of cost of the rented area (including VAT).

2.3.2. To submit additional services listed in the Appendixes to this

Agreement and to pay up these services.

2.3.3. To display the goods fully complying with subjects of the Exhibition.

2.3.4. To avoid the activity leading to blocking up the passes of pavilion or preventing the work of other exhibitors.

2.3.5. At the end of the fair all the equipment should be in working order. In case of damage, the Exhibitor undertakes to make a full payment of the damaged unit.

2.3.6. To maintain the given exhibition area and exhibits in cleanness and the order.

2.3.7. To demount and to remove the exhibits, informational and the promotional materials from the territory of the Exhibition till 18:00 - 18.06.11. If the exhibitor doesn't remove all the exhibits from the fair ground till 18:00 on 18th June 2011, he will pay all the penalties issued by Crocus-Expo to Expo-Mold. The demounting of the stand, exhibits and their removal from the territory of the Exhibition is prohibited up to official closing date of the Exhibition 16:00 - 17.06.11.

2.3.8. To provide the presence of the representative at the stand in working time of the Exhibition.

2.3.9. To observe fire prevention rules.

2.3.10. Health care and injury protection of the representatives working on fair is a duty of the Exhibitor. The organizer bears no responsibility in the event of such an injury.

2.3.11. To have at disposal the documentation on the exhibiting products, information materials, a copy of the Agreement of participation in the Exhibition, etc. on working hours of the Exhibition. The necessary customs documents determined by competent customs bodies of the Russian Federation are required for every foreign product exhibiting.

2.3.12. Not to put the stand at disposal of the third parties, partially or completely, for a payment or free-of-charge, without the written sanction of the Organizer.

2.3.13. Not to transfer the rights and the obligations stipulated in this Agreement to the third part without the written approval of the Organizer.

2.3.14. To send to the Organizer original copies of documents signed: the original of the Agreement of participation and Appendixes to this Agreement.

To send to the Organizer the copies of the mentioned documents by fax. The Agreement signed by the parties and sent by fax is considered as valid preliminary Agreement, according to statement 2 of the Article 434 of Civil Codex of the Russian Federation.

3. ORDER OF PAYMENT

3.1. Exhibitor is obliged to pay for the services provided by Organizer in the following order:

- advance payment equal to 30% of the total amount -- within 3 banking days after issuing of an invoice;

- final payment equal to 70% of the total amount -- not later than 45 days before the opening of the exhibition.

3.2. Booths located on the central lines are paid:

- advance-payment 50% from the total amount of invoice, must be paid in 3-days period from the invoice date;

- 100% payment must be done before the March 15-th 2011.

4. REFUSAL TO PARTICIPATE

4.1. Completion of the Contract-Application and Organizer's receiving it means that Exhibitor agrees to perform full payment according to invoices. In case of refusal to participate after signing of the Application form by Organizer, Exhibitor must inform Organizer about it in written form. The date of receiving the notice by Organizer is considered to be the date of refusal. Refusal implies refusal to participate in the exhibition as a whole or curtailment of the agreed exhibition booth (exhibit space). Exhibitor must pay a fine, the amount of which is equivalent to 50% of the total cost of agreement or the curtailed part if refusal is received later than four months, and 100% if the refusal is received three month before the Exhibition opens. The advance payment is not a subject to return.

4.2. The fine must be paid by Exhibitor no matter if Organizer leaves the space free or passes it to another Exhibitor. Registration fee and cost of the catalogue entry are not returned to Exhibitor. Organizer has the right to refuse to a company wishing to participate, in case its production, printing materials, personnel, etc. do not comply with interests and objectives of the event.

5. OTHER TERMS AND CONDITIONS

5.1. By signing the Present Contract Exhibitor assumes the obligation to abide by the Present General Terms, and current legislation of the Russian Federation. All amendments and additions, introduced to the Contract, must be approved by Organizer in written form. Organizer must consider requests of Exhibitor with regard to the location as far as possible.

Organizer has the right to change location and exhibit space of Exhibitor for technical and administrative reasons. In this case Organizer must inform Exhibitor in proper time. Organizer is not responsible for losses, incurred by cancellation, postponement, curtailment of the exhibitions due to reasons beyond his control.

5.2. Exhibitor provides standard information about his organization for the official catalogue of the exhibition. In case the information is not received before the scheduled date, Organizer inserts material about Exhibitor, based on Organizer's information about Exhibitor.

Catalogue publisher and Organizer are not responsible for mistakes and omissions in materials provided by Exhibitor. Organizer bears no responsibility for the legitimacy and reliability of the information provided by Exhibitor for placement in the official catalogue of the exhibition.

6. RESPONSIBILITY OF THE PARTIES AND RISKS

6.1. Organizer is not responsible for losses, theft or damages done to people or exhibits, in particular, caused during transportation of exhibits to the country of Exhibition and back and their customs clearance. Organizer takes appropriate measures (twenty-four-hour professional guarding, etc.),

6.2. Exhibitor bears property responsibility for the safety of exhibition equipment, supplied for the exhibition period. Any changes in stand construction are accomplished by Organizer on request and expense of Exhibitor.

Exhibitor must fully compensate for damage or loss of exhibition equipment, and for life, health or property damage to individuals caused by Exhibitor's unauthorized redeployment or electrical connection

7. FINAL CLAUSE

7.1. In case Exhibitor breaches the terms of the Present Contract and General Terms, Organizer has the right to refuse an exhibition booth (exhibit space) to Exhibitor. Exhibitor's claims may be lodged in written form not later than the last day of the exhibition. Disputes are settled according to the order stipulated by the legislation of the Russian Federation.

7.2. All conditions that are not stipulated by the Present Contract and General Terms must be regulated by the legislation of the Russian Federation.
